### **EXECUTIVE BRIEF**

**TITLE:**

Resolution No. 10-2015 - certify the results of the Municipal General Election

**SUMMARY:**

This Resolution certifies the results of the election as required by the City's Charter.

**BACKGROUND AND JUSTIFICATION:**



